PERALTA GOVERNING BODY MEETING MINUTES TUESDAY, MAY 14, 2024

THE GOVERNING BODY FOR THE TOWN OF PERALTA HELD A REGULAR MEETING ON TUESDAY, MAY 14, 2024 AT 6:00PM IN THE PERALTA TOWN HALL, 90-A MOLINA ROAD, PERALTA, NM 87042.

1. CALL TO ORDER - Meeting was called to order at 6:04pm by Mayor Bryan Olguin; Governing members present are Councilors Leon Otero, Claudio Moya, Randy Smith. Councilor Joseph Romero was absent.
2. PLEDGE OF ALLEGIANCE - was led by Mayor Olguin.
3. CONSIDERATION AND POSSIBLE ACTION TO APPROVE AGENDA for May 14, 2024. Motion to approve the May 14 agenda was made by Councilor Otero, second was made by Councilor Moya. The agenda was approved.

10. DISCUSSION ITEMS WITH POSSIBLE ACTION:
 - a. Dia de las Fiestas Peralta y Valencia – Date is set for Saturday, October 5, 2024.
 - b. Discussion for Resolution/Ordinance – Appointment of Planning and Zoning Commission. The Town attorney suggested 2 proposals: Councilors to appoint a P&Z Commissioner for a 2-year term; Mayor Olguin recommended the 2-year term. Councilor Smith recommended a one-year term for each P&Z Commissioner. Each P&Z Commissioner would be approved every January Council meeting. Further discussion centered on whether a P&Z Commissioner should be a business/land owner or a blood related/family member. It was finally discussed that any P&Z Commissioner will be independent of any Town Councilor's affinity – any family member – not blood related. This item is to be decided on at the next Town Council meeting.

11. DISCUSSION AND POSSIBLE ACTION

- a. IGA - Intergovernmental agreement for Police Service between the Town of Peralta and the Village of Bosque Farms. Motion to approve the IGA was made by Councilor Smith, second by Councilor Otero. The IGA was approved.
- b. Memorandum of Understanding (MOU) To provide GIS addressing and E-911 services for the Town of Peralta. Motion to approve was made by Councilor Smith, second by Councilor Otero. MOU was approved.
- c. Resolution 2024-010 – Disposition of Obsolete vehicles. Motion to approve was made by Councilor Smith, second by Councilor Otero. Resolution was approved.


12. PUBLIC HEARING – Discussion and Possible Action


