TUESDAY JUNE 20, 2023 @ 6:00PM AT PERALTA TOWN HALL, 90A MOLINA RD.


- 1) Call to order – 6:03 – Commissioner Pacheco, Murphy, Amestoy, and Salazar Present, Commissioner Milavec absent.

- 6) New Business


Proposed Zone Change and Lot split. Land of Sofie Sanchez, Tract: 1 4.03 Ac, Zoned change from Rural Residential to Neighborhood residential. Location 6 Camino De Flores. Mrs. Lisa Flower home sits on 4.03 and is zoned Rural Residential. She is asking P and Z if she would be allowed to do a land split and re-zone one acre into Neighborhood Residential. The residents of Camino De Flores were here in support of the re-zone and the parcel being split into 1 acre (no less than 1 acre parcel) and re-zoned to neighborhood residential. Neil Overbay would like to purchase the lot to build a home. Commissioner Pacheco wanted to make sure that the zone change and the lot split would conform to the surrounding neighborhood.
